The Absentee Counting Board will convene at 4:00 pm on Election Day. Canvassing of the machines will be conducted on November 9, 2016 beginning at 12:00 noon in the Election Commission Office, 901 Main Street, Suite 108, Maynardville, TN 37807.

Voters who vote in person during early voting or on Election Day must present a photo ID issued by the federal or Tennessee state government. These IDs may be current or

expired. College student IDs and photo IDs issued by cities, counties and other states will not be accepted.
